

# Hygiene concept Municipal Galleries Tempelhof-Schöneberg

Senate Department for Culture and Europe from 25.09.2021.

The locations of the municipal galleries can be visited in compliance with the hygiene rules. With our hygiene concept we want to ensure a smooth visit and protect visitors and employees as best as possible from infection. All the measures listed comply with the specifications of the above-mentioned hygiene concept and the Second Sars-CoV-2 Infection Protection Measures Ordinance:

**When visiting our galleries, the AHA-L rules apply. In the predominantly flowing visitor traffic, no contact data collection is necessary. It is only a prerequisite for visiting events in closed rooms.**

### **Mandatory testing**

Presentation of a certified negative antigen test is not required to visit the exhibitions.  
For indoor events, the 3G rule applies. In individual cases, the 2G rule may be applied.

### **Mask**

Wearing a medical or FFP2 mask is mandatory throughout the duration of the visit to the house.

### **Distance rules**

Care must always be taken to maintain a distance of at least 1.5 metres from other persons. Since it is not possible to set up separate entrances and exits at our locations, special attention must be paid to maintaining the distance and the exit before entry rule in this area. The visitor service points out the direction through the exhibitions and ensures compliance with the AHA-L rules.

### **Disinfection**

Visitors can disinfect their hands when entering the exhibition buildings. Disinfectant is available at the entrance to each location. Contact surfaces that are touched by the public are regularly disinfected according to a plan.

### **Ventilation**

At all locations, the Visitor Service ensures that sufficient and regular ventilation is provided on the basis of a plan. Rooms that are not ventilated are closed to visitors.

### **Maximum number of persons allowed**

The maximum number of persons allowed depends on the total size of the exhibition space.

**Each visitor has 5 sqm at his/her disposal, groupings are to be avoided.**

In practice, this means for the sites:

**Haus am Kleistpark I Large exhibition hall:** 16 persons at the same time per large room, incl. supervision

**Haus am Kleistpark I Project room:** 6 persons at the same time per room, incl. supervision

**Gallery in the Tempelhof Museum:** 10 persons, incl. supervision

### **Protection of employees**

At each location, the visitor service workplace is equipped with a spit shield. All employees are provided with FFP2 masks and two antigen tests per week.

### **Additional rules at individual sites**

In order to be able to look at books/catalogues or touch interactive exhibition objects, the wearing of gloves is obligatory. Disposable gloves will be provided.
